- 3. Chairman's Report

Chairman's Branch Report 2017

2017 was a busier year for the North East and Cumbria Branch and a busy time again for the Region regarding workload.

The A1(M) Leeming to Barton saw completion to the widening scheme in July 17 with improvements in journey times immediately apparent.

The continuation of work on the new Silverlinks Interchange in North Tyneside and works at the Lindisfarn Interchange in South Tyneside should all see improvements along the A19 corridor in Tyneside.

The new Wear crossing is nearing completion with the main asphalt paving works and tie ins the only outstanding items

Local authorities budgets however came are still under pressure in 2017 and maintenance budgets saw a further decline. This has however been balanced by 'pot hole' and 'flood damage' capital across the Region securing a large proportion of this value stream for repairs to the network.

Membership in the branch has stagnated again at around the 50 members and this year saw a drive to improve numbers and in particular with student membership.

In March we held a Social Evening at Ramside Hall to celebrate 50 Years of the IAT. This included gaming tables where members and guests could chance their arms and not their wallets using the not for profit cash vouchers provided!

April saw our Branch technical evening focus on the Local Morpeth Bypass scheme with a presentation by Carillion on a Computer Generated Construction Model which allowed structures to be 'built' and any potential issues to be ironed out prior to the 'actual' Construction phase of the works.

September brought our annual training day at the Ramside Hall in Durham which was again well attend with 51 delegates and remains our most popular Branch Event. Speakers included MacRebur – updating on their efforts to get our Industry to recycle more Plastic into our Asphalt products. Dr Robert Hunter gave an update on the combined Asphalt Standard BS 594987. There was a session then on Sampling Best Practice delivered by Allan Moffett and an overview of the A1 Leeming to Barton Project by the Scheme Director David Lowery.

Our Branch Technical Event in October was a Site Visit and Project overview for the New Wear Crossing presented by the Construction Main Contractor Farrans. This was a joint visit with the Concrete Society and again was well attended by both Branch Members and guests (photos attached)

In 2018 we are looking forward to hosting the 2018 National Conference with a theme of Highways Innovation – Asphalt Technology Solutions and a hopeful boost in membership as a result of the Institute exposure this will bring
